WBPF VICE - PRESIDENT FOR ASIA MR AMIR BAYAT SWIPS AT IFBB IN IRAN

Last week, a news was posted on the federation website about Amir Bayat's meeting with the federation chairman of IFBB IRAN, who mentioned that Amir Bayat as a pioneer of bodybuilding in Iran. The President of IFBB Iran admired the performance and success of Mr. Amir Bayat. During Bashir's conversation with Amir Bayat of the meeting the following was discussed. The meeting was about the WBPF and IFBB standing position and it was suggested that the Ministry of Sports are the experts to examine and comment of which of the two organization is closer to the Olympics ideals. Rafael Santoja path over the last ten years from Bodybuilding has gone a little too far as he was degrading sports by displaying clothes and shows instead of competition. It has brought down the image of fitness and a great mockery to sports of fitness in general. The public of community viewed IFBB's presentations as a glamour show instead of a sports event. Another important point the great weakness of IFBB in Asian they lost complete respect from the majority of the Asian countries. Amir Bayat highlighted the competition held in Lebanon for their IFBB Asian championships where only number of 5 countries participated.



Amir Bayat told Mr. Paul Allrad that in the separation of the federation, Iran bodybuilders should not be suffering by these differences. For example, the bodybuilding association with WBPF and the federation of IFBB.

Rafael accuses the NPC Federation of promoting professional sports and unsupervised doping, but he has also set up professional organizations that are unsupervised on Doping. Rafael on one hand promoting fitness sports with clothing line and fitness challenge that it brings performance and power movements into competitions and on the other hand hold professional competitions that are far from the Olympic charter. Our desire was that our association participate in the WBPF amateur bodybuilding competitions with the approval of the federation and recognized by the Ministry of Sports. Bayat as the president of the Bodybuilding Association running the WBPF and as the Vice President for Asia of the World Federation was present at this said meeting, he is involved over twenty-four years in the sport of bodybuilding and connected with the Asian federations and Iran Sports. His experience is unique and a very experienced and knowledgeable person in bodybuilding and fitness in Iran. Mr. Nasirzadeh did not even bear these titles or being a bodybuilding pioneer.

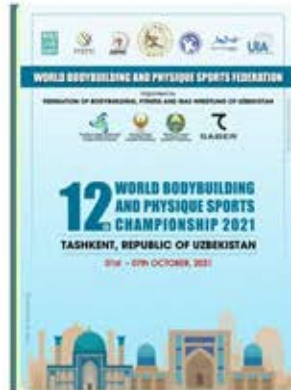
